## Portfolio Summary

It has been a busy month for the PURE team, with a restructure (OLI.ASX), two new position commitments (one funded – SPA.ASX) for >\$6m, a \$20m co-investment loan executed for cornerstone investment company Tesserent, and substantial headway made on the Resources Fund raise. Despite the quantum of dollars deployed this month, the team remains engaged on at least a further \$27m in investment opportunities, likely to be executed in April. # PURE Resources Fund

The Investment Team has been actively marketing the PURE Resources Fund over recent weeks, with positive feedback received from investors. As described in our February newsletter, the product takes the IP and structuring established in our flagship PURE Income & Growth Fund, then tailors it for the risks inherent to resources investing. We believe the product structure, combined with an impending mining capex cycle, provide an asymmetric opportunity to grow a fund in an historically under-funded sector.

The investment team has been speaking to potential borrowers over recent weeks. High levels of engagement have been received, with the team now discussing some highly prospective opportunities. We are encouraged by both the quantum of opportunities to hand and, on face value, the asymmetric nature of these investments.

#### Deal Flow

The PURE Investment Team continues to work through multiple transactions at various stages of completion. As outlined above, we have recently closed a transaction with Spacetalk, while a modest pre-IPO position has also been initiated (subject to shareholder approval).

Subject to reaching binding terms on one additional transaction discussion that is in advanced stages, PURE intends to reopen the Fund for additional investment in April.
