Dear Investor,

We enclose the May 2021 update for the PURE Income and Growth Fund. An overview of our returns and portfolio comments are detailed below.

After closing to new applications from November 2020, we are pleased to report the PURE Income and Growth Fund is again open for investment.

The deal pipeline remains exciting, with multiple transactions moving towards close over the coming weeks.

Portfolio Summary

After a frustrating March quarter for the Fund, it was pleasing to see positive performance return in April. Rising bond yields, increased volatility, and a powerful rotation from growth to value have proved a difficult operating environment year to date.

The month's positive performance was primarily attributable to the agreed restructure of LAW Finance (see April newsletter), along with a rebound in the equity prices of Mighty Craft and Xref.

We appreciate the fact that stocks don't go up in straight line. While the consolidation period has been disappointing, it has rebased the warrant/equity exposure within our portfolio. Much akin to early 2020, we believe this dynamic has set the Fund up for a strong run into year-end:

Income & Growth Fund Deal Flow

After a period carrying more cash than targeted, the PURE Income and Growth Fund has reopened in response to a significant deal pipeline. The Investment Team is in the final stages of multiple transactions, importantly with metrics comparable to the balance of the portfolio. One trend has been the emergence of multiple highly attractive private / pre-IPO opportunities. We continue to monitor this space and expect portfolio capacity to become available as Orbx, Hydralyte and FiscalNote IPO over the coming quarter.
