Fund Overview

The PURE Income & Growth is an absolute return fund which is focused on emerging growth companies, and targets double digit returns over a 3-5 year investment cycle. The Fund's unique strategy is to invest in self-originated hybrid securities (convertible notes or combined note & warrant structures).

The benefit of the strategy is that it provides investors: capital protection; consistent income; and equity upside. The Fund can generate superior risk adjusted returns by exploiting the structural and consistent failure of the stock market to provide targeted companies with access to growth capital at a reasonable price.

How we Invest

The Fund predominantly invests in emerging ASX listed industrial companies and typically initiates an investment through senior secured debt, with full convertibility into equity. Until converted, the debt carries an interest rate of 8-13%, meaning the Fund gets 'paid to wait' for the equity opportunity to mature.

The portfolio is primarily built by transacting directly with a Company after extensive due diligence, using our in-house deal origination, structuring expertise, and legal advisors. As a debt investor, the Fund is afforded more insight into the Company's operating performance than equity investors.

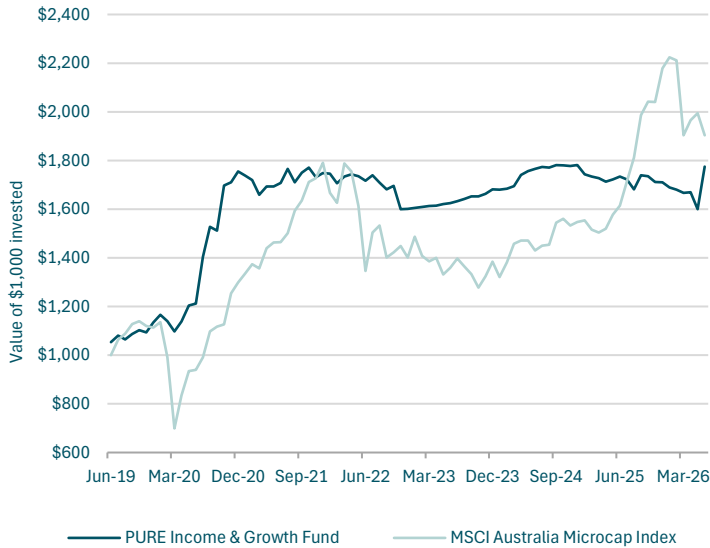
Superior due diligence and secured debt structures significantly reduces the risk of loss. The interest charged provides consistent returns. The convertibility into equity provides opportunities for material upside. Collectively, these benefits are expected to increase the likelihood of alpha generation, compared to other absolute return strategies or equity portfolios.

At any time, the Fund will hold up to 50 positions and is able to invest in equity securities, corporate credit, hybrid securities, options, warrants and cash.

- Targeting market leading risk-adjusted returns via differentiated economic exposure to emerging companies.
- Entering via credit means the Fund's capital is higher ranking than equity, thereby protecting investor capital.
- Lower expected Fund unit price volatility, compared to standard equity absolute return funds.
- Credit level due diligence and rigorous documentation aim to provide superior investment analysis.
- Quarterly income distributions (targeting +7.0% p.a.)
- PURE's investment team has 100+ years of combined experience in financial markets.

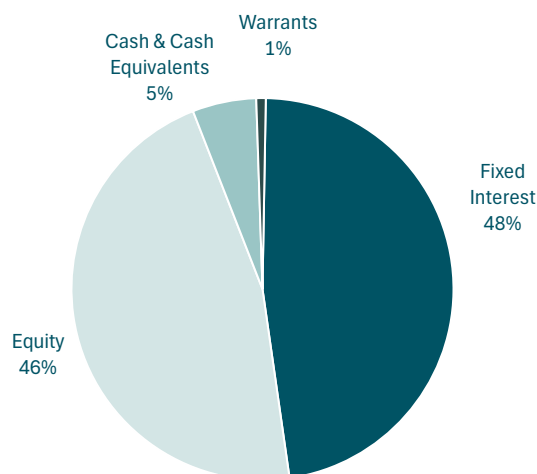
